2) MURALIST RECOMMENDATION FOR THE TEMPORARY SOUNDWALL TO BE INSTALLED ON NORTH CANON DRIVE AT WILSHIRE BOULEVARD DURING CONSTRUCTION OF THE WILSHIRE/RODEO STATION OF THE METRO PURPLE LINE EXTENSION PROJECT

Project Manager Robert Welch presented an overview of the process leading to selection of a consultant to work with Stakeholders, Next Beverly Hills Committee and the Staff to recommend an artist for a temporary mural on the N. Canon soundwall. The Liaisons stopped the presentation and asked Staff if they had requested that the Fine Art Commission review the artist selection before coming to the Liaisons. Staff and the Fine Art Commission Chair and Vice Chair indicated that the artist selection was not presented to the Commission as a whole. The City Council liaisons instructed staff to bring this item to the upcoming Fine Art Commission meeting on February 21, and then bring their recommendation back to the CC/FAC Liaisons. The stakeholders in attendance at this meeting discussed with the Liaisons, staff and the consultant the criteria and urgency for this mural.
